

**Waiver of liability Relating to Coronavirus/COVID-19,
Agreement to Abide By Safety Protocols and Notification Requirements**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. The use of these services and facilities is of such value to me [and/or to my children,] that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize Santa Barbara Creative Education sponsored by the D'Arezzo Center, Services and Center's facilities.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against Santa Barbara Creative Education sponsored by the D'Arezzo Center, and their respective board members, directors, managers, officials, trustees, agents, employees, affiliates or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Santa Barbara Creative Education sponsored by the D'Arezzo Center, 2300 Garden Street and 2324 Santa Barbara Street and Field Trip facilities. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

AGREEMENT TO ABIDE BY SAFETY PROTOCOLS: I have been provided with a copy of Santa Barbara Creative Education sponsored by the D'Arezzo Center's written safety protocols. I have read and I understand these safety protocols. I agree to fully comply with the safety protocols. I acknowledge that if, at the sole discretion of Santa Barbara Creative Education sponsored by the D'Arezzo Center, and/or 2300 Garden Street and 2324 Santa Barbara Street and Field Trips representatives, it is determined that I am not fully complying with the safety protocols, I will

be precluded from further use of Santa Barbara Creative Education sponsored by the D'Arezzo Center, .

I consent to allowing Santa Barbara Creative Education sponsored by the D'Arezzo Center's representatives to notify staff and other users of the facilities that another user of the facility tested positive for COVID-19, without identifying me by name.
